2017-2019 AFSA Governing Board Election Candidates' Statements

Barbara Stephenson for President *

As head of the Strong Diplomacy slate, I thank all the AFSA members who voted for me and for the whole slate in the 2015 elections. I asked you then, as I am asking you now, to cast your vote for a strong slate of candidates united around a compelling governing vision: every decision we take as AFSA Governing Board members will be based on what makes the Foreign Service stronger--in fact and in reputation.

With my commitment to transparency and accountability as foundations of good governance, I have used the President's Views columns in the Foreign Service Journal to keep you informed of the Board's work. We developed an agreed strategy built around three pillars or lines of effort:

Inreach, to understand fully members' aspirations and concerns, which drive AFSA's advocacy agenda with Department management and on the Hill;

Workforce planning, to give AFSA the capacity to serve effectively as the principal advocate for the long-term institutional well being of the Foreign Service, a competitive "up or out" service established by the Foreign Service Act of 1980; and

Outreach, to raise awareness of the vital work of the Foreign Service and develop a domestic constituency prepared to defend us.

Our abiding commitment to good governance also led us to undertake reforms to improve governance at AFSA. Our annual budget process increasingly reflects the strategic vision of the Governing Board, which is, as the bylaws make clear, responsible for governing AFSA in the interest of our members. Our committee structure and minutes process now comport with established best practices. If Strong Diplomacy is returned to the Governing Board, expect further work to improve AFSA governance so that member dues are used as efficiently and effectively as possible for the benefit of the Foreign Service.

Resources permitting, we will strengthen Congressional advocacy efforts, drawing on AFSA's new Ambassadorial Advisory Council to chart an effective course and represent the Foreign Service in meetings on the Hill. And, resources permitting, we will further expand outreach efforts so elected representatives know how much their constituents value the Foreign Service, whether that is farmers who appreciate our

work to open markets for their crops or members of AFSA's strategic partner organizations (Global Ties, World Affairs Council) who share our commitment to global engagement and have deep roots in their communities across the 50 states

A vote for me and fellow Strong Diplomacy candidates is a vote for continued work by a united Governing Board to make the Foreign Service stronger. We know from repeated polling that nine in ten Americans favor strong American global leadership. And we know from experience that such leadership is unthinkable without a strong, career professional Foreign Service. The stakes are high and the challenges facing the Service serious. Fortunately, the candidates for Strong Diplomacy include some of our profession's most skilled and sophisticated advocates. I am grateful to each of them, including Strong Diplomacy founding member and AFSA secretary Bill Haugh, for stepping forward to serve. Use your vote to put them to work for you, for a strong Foreign Service, and for continued American global leadership.

Bio note: Barbara Stephenson has served as president of AFSA since July 2015. As Dean of the Leadership School at FSI (2013-2015), she launched a Department-wide dialogue—the Leadership Roundtable—to improve leadership and management to unleash the tremendous talent at State. She served previously as Ambassador to Panama and DCM/Charge in London. She won a Distinguished Honor Award for delivering the "civilian surge" to Iraq--without breaking the back of the Foreign Service. She also served as Consul General in Belfast and CG and COM in Curacao and received a Superior Honor Award for her work on the peace agreement in El Salvador. With over thirty years of service, she entered as a political officer and has since served interfunctionally, meeting the needs of the Service whenever and wherever called.

Tom Boyatt for Secretary *

We in the Foreign Service are fortunate to have the opportunity to participate in two rewarding universes: the formal world of our careers as Foreign Service officers and Specialists, and the alternate world of AFSA. The latter supports the former and both are dedicated to the most effective possible

American diplomacy in the nation's service.

Entering the Service before cones existed, I was both a consular and administrative officer in Antofagasta, Chile; an economic officer during a stint at the Treasury and later economic "counselor" in Luxembourg; political counselor in Nicosia; country director in NEA; DCM in Santiago; and Ambassador to Upper Volta and to Colombia. I count myself very lucky to have served in all of the cones and four of the five geographic bureaus of my day.

In AFSA world I have served as post representative in Nicosia; Vice President in charge of elections competing against AFGE to represent State, AID and USIA; President during our initial negotiations with management regarding personnel policies and procedures; Treasurer multiple times as well as a retiree representative and retiree Vice President for the last two years. For more than 50 years I have had the privilege of working in the AFSA context with several generations of very talented Foreign Service colleagues to pursue the best interests of the Foreign Service itself and its people. I would not trade my experiences in both worlds for anything.

The Strong Diplomacy slate since 2015 has worked for a more efficient Foreign Service and supported AFSA as its principal advocate. I have pursued the same objectives my entire professional life. During the last two years under Barbara's inspired vision AFSA has made great progress on the three pillars: outreach to the public and Congress, in-reach to assess member views, and the development of a transparent and viable work force planning model and process. Undergirding all of this has been Barbara's leadership in driving significant improvements in the governance of AFSA in fulfillment of our fiduciary responsibilities. Much remains to be done and I am honored to part of the Strong Diplomacy Slate in the 2017 elections.

There are also potential external challenges in the form of a new Foreign Service Act and/or possible changes to the statutory basis of our employee-management system. We are monitoring these situations and discussing any necessary responses.

Given the work still ahead and the potential challenges, I ask you to vote for me and my colleagues on the Strong Diplomacy Slate. We are fully committed to the tasks ahead, and to leaving a better and stronger AFSA and Foreign Service to our successors.

Earl Anthony (Tony) Wayne for Treasurer *

I am very pleased to be part of the Strong Diplomacy slate as the candidate for Treasurer. The vision we share -- that every decision by AFSA's Governing Board members should be guided by what makes the Foreign Service stronger in fact and reputation -- is as important as ever, given the serious challenges we may well face as professionals in the years ahead. Bio note: Earl Anthony (Tony) Wayne served in the Foreign Service from 1975 to 2015. He was confirmed as a Career Ambassador in 2010. Wayne served as the U.S. Ambassador to Mexico (2011-15), Deputy Ambassador and Coordinating Director for Development and in Afghanistan (2009-2011), and U.S. Ambassador to Argentina (2006-2009). Wayne was Assistant Secretary of State for Economic and Business Affairs (EB) from 2000-2006. Prior to EB, Wayne worked as Principal Deputy Assistant Secretary of State for European Affairs, Deputy Assistant Secretary for Europe and Canada, and Deputy Chief of Mission at the US Mission to the European Union, among other posts. He received a number awards during his State Department career, including the Cordell Hull Award, the Charles Cobb Award, and the Department's Distinguished Honor award.

Wayne is currently a Public Policy Fellow at the Woodrow Wilson International Center for Scholars, a nonresident senior fellow with the Atlantic Council's Global Business and Economics Program, and a non-resident senior adviser for the Center for Security and International Studies. He is a consul-

tant, including for HSBC Bank in Latin America on countering illicit finance. He also chairs AFSA's Political Action Committee.

Wayne has Masters Degrees from Harvard, Princeton, and Stanford, and a BA is from UC Berkeley.

Joe De Maria for State VP

You do have a choice.

I am Joe De Maria and I would like you to elect me State Vice President of AFSA. I am a consular officer with more than 25 years' experience with service in seven countries and five Washington bureaus.

I am running to serve everyone in the bargaining unit and to protect our right to organize and bargain collectively.

In the best spirit of consular service, I promise to be accessible and focus on customer service. Do you know your AFSA Officers personally? As office hours, I will have lunch and breakfast at the cafeterias in HST and FSI on published days several times per week, when anyone can join me and talk about anything, with no appointment. I will never forget I work for you and serve at your pleasure.

I am running against a slate of long-serving AFSA officers who have done a great job dealing with management for several years, but like all other public employee unions, AFSA now is under threat to its very existence. It has been reported that the White House is looking to the example of Wisconsin as a model to degrade government unions. Members of Congress are planning to end the decades-old right of federal employees to have fair representation in the workplace. Right now, the issues are the use of official time for union business, like resolving disputes, and spreading free rider ("right to work") laws, but it won't end there. They will cite a report that links public sector collective bargaining with increased public spending and say unions have no place in government. Their position used to be: "When we get the unions to the bargaining table, we're going to win." Now, their position is: "We're not going to let them get to the bargaining table." There is a big difference.

At a recent meeting of AFSA candidates, a member of the Strong Diplomacy Slate said such concerns are speculative. I hope he's right and I'm wrong, but we must be proactive to counter such ideas. We can do that by working with the other two unions which represent State employees and our organized coworkers throughout the federal government and beyond. Otherwise, AFSA will simply be a professional association with no input into the terms and conditions of work. As

our first diplomat, Benjamin Franklin, said, "If we don't hang together, we will surely hang separately."

Further, management should support AFSA in its own interest. Management and the Foreign Service have enjoyed a healthy, cooperative relationship for decades, which has made our Foreign Service the global standard for excellence and our foreign policy strong. That partnership should not be questioned.

Please vote for me this spring.

Kenneth Kero-Mentz for State VP *

I believe having passion for the job makes the job. And I have loved the State Department, the Foreign Service, and AFSA – our union and our association – since I joined State over 17 years ago. Now I want to channel my passion to advocate for you as your next AFSA Vice President for State. Over the years, I have seen a number of changes and improvements – more diversity and greater training for supervisors and managers, to name just two. But in these, and other areas, there is still more we can and must do to make this institution I love (and which I suspect you do too) stronger in the face of challenging times.

I know our bureaucracy can be tough to navigate, and tougher to change. Advocacy can be difficult, but it is critical, especially when the challenges seem most daunting. I have a proven track record of using my passion to move State forward, helping others, and achieving positive outcomes for my fellow employees.

Early in my career, I volunteered as AFSA's Post Representative twice and won the AFSA Post Rep of the Year award in 2009 while in Berlin. Upon returning to Washington, I served two terms on the AFSA Governing Board, first under the leadership of Susan Johnson and later with Bob Silverman. I learned a great deal from both and was proud to support Barbara Stephenson and her Strong Democracy slate in 2015. This year, I'm even more proud to join the Strong Diplomacy slate as we work together to support and promote the Foreign Service.

Outside AFSA, my passion for advocacy has also supported GLIFAA, the organization representing the foreign affairs LGBT+ community. My time on that Board, and particularly the year I served as GLIFAA President taught me valuable lessons on dealing with the Department's senior leaders on controversial, but needed, reforms. Prior to joining State, I spent five years on Capitol Hill, giving me insight into working successfully with Congress as well. Finally, my assign-

ments abroad (in Erbil, Baghdad, Colombo, Berlin, and Rio de Janeiro) and in Washington (in EUR and DRL) give me the breadth and depth of experience needed to represent the diversity of our service and advocate for our unique needs.

I believe AFSA must be a place where everyone can share concerns and ideas, safely. During this critical time, I want to work for you and with you to support and improve this organization, this institution, which inspires our passion. I know how to work with senior management, and I know how to advocate for our foreign service and our Department. I ask for your vote, and I look forward to hearing from you in the coming months.

Ann Posner for USAID VP

USAID's achievements are noteworthy. Its highly skilled and dedicated work force of professional Foreign Service Officers (FSOs) are a considerable weapon to combat poverty and disease and to create sustainable societies dedicated to democratic principles, gender equality and economic growth. And we must continue to help in countries that face the terrible realities of extreme weather, famine, regional conflicts and corruption. The demands of these challenges can place pressure upon our Foreign Service Officers. They may live and work in difficult and hazardous conditions and endure separations from their families.

Rajiv Shah, former USAID Administrator stated recently; "Health and development spending has evolved into a rigorous, innovative and professional enterprise dedicated to measured outcomes. Aid and development practitioners know how to set smart targets, engage private-sector partners, adapt to changing circumstances and make sure taxpayers get the most value for their investments. And they have evidence that what they are doing works."

With 19 years as a FSO in USAID and another eight years as a Foreign Service spouse -"eligible family member" I bring my first-hand experiences in USAID missions within US Embassy communities to bear. As Constituency Vice President for USAID, I will call upon my knowledge and years of experience as a USAID Executive Officer to represent the perspectives and concerns of FSO's and their families.

Knowing that USAID is vigorous and innovative and we constantly adapt to changing circumstances and situations, I will collaborate with Foreign Service colleagues in the State Department and other Foreign Affairs agencies to be sure that our voices and our unique perspectives and history are considered in our Government's foreign policy agenda.

Steve Morrison for FCS VP

Standing up to Management is not easy or something that should be taken lightly. I have only acted with your best interests at heart using the courage and wisdom that comes from a 20-year Foreign Service career and 10 years working in Washington prior to joining the Commercial Service.

As an example, I stood up to Management abuse no fewer than three times in just the past 12 months. Last year, Management mistakenly misled several officers into postponing language training until I stepped in, pointed out the dangers to those officers' careers and families, and – working with the affected officers -- Management's decision was reversed. About the same time, other officers began receiving word that pre-retirement training was being canceled. I objected, filed an Implementation Dispute, and negotiated a restoration of classes and MOU. Along the way, Management admitted that "the change was a mistake" and that "the Foreign Service is different" (i.e., needs to be protected).

Similarly, you know the lengths I went to -- and risk I ran -- pointing out Management excesses with respect to travel. As a result of our work, trips were canceled and money was saved for real trade promotion. I fought forcefully, honorably, wisely, and in person and in writing. I did not quit.

The job of AFSA VP, thankfully, is not all about opposition and thus I can point to many instances where AFSA and Management worked together to improve the Commercial Service such as changes to the composition of Selection Boards (that led to better and faster awards and promotions), a revived When Actually Employed program, and TDY Lodging.

As for the future, Suzanne and I began working on outreach even before 2016 was in the record books. We met and discussed Hill priorities with our colleagues in December. I subsequently met with Senator Cory Booker's staff and Appropriations Committee staff regarding resources. It goes without saying that ITA's budget is under tremendous pressure and 2017 is shaping up to be a "make-or-break" year for the Commercial Service.

In sum, now is not the time to "change horses." The new Administration has been encouraged to engage in "straight-out war" against long-standing protections. Labor law is complex and thus my esteemed AFSA colleague wrote, "I am a political officer, but I've engaged in more negotiations during this assignment than during any of my overseas postings." The CS AFSA VP is the primary negotiator for personnel matters before the Commercial Service. It is the final backstop to potentially disastrous new or changing policies directly

affecting your career. In times like this, you need a fighter and a finisher. I am that person and thus hope you will re-elect me as your AFSA VP.

Daniel T. Crocker for FCS VP *

Barbara Stephenson is leading the Strong Diplomacy slate for AFSA. I'm asking for you to vote for our team. And I'm asking you to vote for me as your FCS VP on that slate. There are three reasons.

First, we need a unified Governance Board representing our interests. Barbara's leadership is exemplary in this regard – she's drawn an outstanding team together. When she was Ambassador to Panama, I served as her SCO and can attest to her recognition of the importance of FCS as a core member of her senior staff. I will leverage this data, our US and foreign network, and associations and clients to raise our profile much more dramatically. I will give you data-rich briefs for the Codels you host. I will challenge Commerce where needed to ensure that our budget is spent on giving us what we need to deliver for our clients. I will be boots on the ground for you in DC. John K. Naland for Retiree VP

It goes without saying that the Foreign Service today faces unique challenges. We retirees can, indeed must, help AFSA confront those challenges. To start, we need to rethink the role of the Retiree VP. Traditionally, Retiree VPs have been distinguished former senior officers whose myriad of other

activities (lecturing, consulting, traveling, etc.) left only a few hours a week to dedicate to AFSA. That limited role may have been adequate in the past, but it is not today.

The Administration is proposing deep cuts in funding for diplomacy as well as drastic changes to federal retiree benefits (some of which could impact current retirees). Congress is considering changes to union "official time" rules that would force AFSA's President and active duty VPs to either go on LWOP to remain full-time AFSA officers or to limit their union activities to lunch hours, evenings, and weekends.

Given these threats, the next Retiree VP needs to do more than attend a few AFSA meetings a month and write four Foreign Service Journal columns a year. If you give me your vote, I pledge to dedicate 20 hours per week to AFSA. Not only will I devote time and energy, but I will do so employing uniquely-relevant expertise and experience.

As you may recall, I served as AFSA President (2001-3 and 2007-9) and AFSA State VP (1999-2001). Those were periods during which AFSA fought hard for funding for diplomacy and development and secured key legislative victories including Overseas Comparability Pay. If elected Retiree VP, not only will draw on that experience when advising the AFSA Governing Board, but I will take an active role in defending the Foreign Service to Congress, the media, and American people.

I have also sat on the other side of the labor-management negotiating table. As the immediate past Director of the Office of Retirement (2011-15), I have deep knowledge of our Foreign Service retirement system (indeed, AFSA turned to me to write the summary in pages 10-15 of your 2017 AFSA Directory of Retired Members). If elected Retiree VP, I will use my expertise to assist retirees who turn to AFSA with questions or problems. When needed, I will meet with the Office of Retirement and the Retirement Accounts Division.

Last summer when AFSA President Barbara Stephenson presented me the 2016 AFSA Achievement and Contributions to the Association Award, I said I hoped the award would be a mid-term evaluation of my contributions to AFSA instead of a final grade. As retiree representative on the AFSA Board, I would support retiree matters, including better treatment of WAEs (a problem I've experienced). But our historic moment demands a larger vision – one where retirees have a special place.

A year ago I began warning President Stephenson and other Board members about views advocated by Donald Trump, including a Muslim travel ban, resumption of torture, disparaging the U.S. human-rights record, unjustified pro-Russia statements, attacks on trade agreements, and separation from NATO and our European allies. I expressed concern that a Trump administration would have difficulty attracting qualified staff, suffer from erratic policy direction, and have little understanding of or use for a professional Foreign Service. I called on the Board to speak out about these dangers.

These concerns were treated contemptuously and dismissively. They are now the substance of everyday news, and the administration is planning major cuts in the budget of a State Department left drifting and demoralized.

AFSA should use its independent voice to address such issues, and retirees – who are less vulnerable than active-duty staff – should take the lead. That would truly be "strong diplomacy," and if elected I would advocate doing so. AFSA should not be partisan or reckless, but it must support a principled and professional Foreign Service.
